### BIOGRAPHICAL SKETCHES RSOL National Conference Speakers Washington, DC, June 2010

#### Amy Borror, Esq.

Ms. Borror is the Legislative Liaison for the Office of the Ohio Public Defender. Since 2004, she has served as the office's spokesperson and as its lobbyist at the Ohio General Assembly. Prior to joining OPD, Amy worked at the Ohio Senate, the Ohio House of Representatives, and the Ohio State Bar Association. Much of Amy's work has focused on Ohio Senate Bill 10, which implemented the Adam Walsh Act in Ohio. She coordinated lobbying efforts that convinced Ohio's legislature to greatly limit the bill's impact on juveniles and to not apply the bill to those who reenter the justice system for unrelated offenses. Since then, Amy has assisted Ohio's criminal defense bar in challenging the new law, and has educated attorneys, treatment providers, child advocates, and the media about the impact the AWA has on children, families, and public safety. In March 2009, Amy was one of seven invited witnesses to testify before Congress at the House Judiciary Subcommittee on Crime's hearing on barriers to states' implementation of the AWA.

#### Gary Dennis, Ph.D.

Dr. Dennis is the Justice Department official overseeing the Second Chance Act. Professor Dennis is presently the Senior Policy Advisor for Corrections in the Department of Justice, Office of Justice Programs, Bureau of Justice Assistance in Washington, D.C. Prior to assuming this position, Dr. Dennis was a Senior Associate with The Moss Group, Inc., in Washington, D.C., serving as Project Coordinator for a cooperative agreement with the National Institute of Corrections for the implementation of the Prison Rape Elimination Act. Dr. Dennis retired from a 34-year career the Kentucky Department of Corrections in 2004. Dr. Dennis has also served as Director of Management and Training Services at the National Institute of Corrections' National Academy of Corrections in Boulder, Colorado, and as Interim Facility Executive for the Vermont Department of Corrections, managing their nine prisons.

#### Chrisanthi Leon, PhD, JSP

Dr. Leon is Assistant Professor of Sociology and Criminal Justice at the University of Delaware, where she teaches an advanced course in sex crime and punishment. Her doctoral thesis is "Compulsion or Desire: Sex Crime & Criminal Justice Policy in California." Her numerous articles include (with Franklin E. Zimring) "A Cite-checker's Guide to Sexual Dangerousness" (Berkeley Journal of Criminal Law, 2008). She has been a speaker at several sex offender support and reform conferences, including the Georgians for Reform conference in March this year.

#### J. Tom Morgan, Esq.

For 12 years, J. Tom Morgan served as District Attorney of DeKalb County. He now specializes in criminal defense and general civil litigation and is licensed to practice law in Georgia and North Carolina. He enjoys the highest rating (AV) issued by the Martindale-Hubbell Law Directory and has been recognized as a Georgia Super Lawyer in general litigation by his peers. J. Tom is known for his competence, commitment, and passion in representing his clients. He is the author of Ignorance Is No Defense: a teenager's guide to Georgia Law (2010).

#### Norman A. Pattis, Esq.

Attorney Pattis is one of Connecticut's best known and most passionate criminal defense lawyers and civil rights attorneys. Notable civil rights cases include successful suits involving millions of dollars for a prisoner beaten during an escape attempt, Hispanic firefighters in a reverse discrimination case, and on behalf of Connecticut's highest-ranking female firefighter. He has wide experience in cases involving serious sex offenses, and in defending indigent sex offenders, appearing before the U.S. Supreme Court in a prisoner's rights case. He has served on the staff of Wyoming Trial Lawyers' College and the faculty of the National Institute of Trial Advocacy. He is the author of numerous articles on criminal law, including weekly columns for the Connecticut Law Tribune. He is also the author of a work of fiction, Dark Justice, which appeared in serial form in the Law Tribune.

#### James L. Powell, PhD, DD

Rev. Dr. Jim Powell is both an ordained minister and a licensed psychologist. He provides psychological treatment and expert witness work in several areas, especially with child molestation cases. He provides treatment for both the offender and the victim. He also is starting his fourteenth year as pastor of an inner city church in Atlanta. Jim has been the president of a graduate school that trained students in theology and psychology, and he enjoys teaching and speaking. His wife, grandchildren, and dogs complete his life..

#### Nancy M. Steele, PhD

Dr. Steele, a Clinical Psychologist, supervised sex offender prison programs in Minnesota and Ohio and facilitated outpatient sex offender therapy groups in Indiana. She has worked as a therapist treating adolescent and adult sex offenders in several states, developed a training program for a halfway house for sex offenders leaving prison, and provided expert testimony for prosecutors and defense attorneys in judicial proceedings involving sex offenders. Dr. Steele is consultant to the National Institute of Corrections to develop state treatment programs, and designed and taught a course at the National Academy of Corrections on developing programs to treat and supervise sex offenders. She has authored numerous articles in scholarly publications and chapters in several books dealing with sex offenders and sex offender treatment.
